**THE COURTS DO NOT ACCEPT A TELEPHONE CALL AS AN APPEARANCE BEFORE THE COURT, IF YOU DO NOT MAKE DISPOSITION ON YOUR CITATION BY ONE OF THE OPTIONS GIVEN ON THE COURTESY LETTER YOU MUST APPEAR BEFORE THE COURT IN PERSON OR BY COUNSEL ON THE APPEARANCE DATE SHOWN ON YOUR CITATION. WHEN YOU APPEAR BEFORE THE COURT ON SAID DATE YOU WILL BE GIVEN ALL OPTIONS OPEN TO YOU TO DISPOSE OF YOUR CITATION. FAILURE TO APPEAR WILL RESULT IN AN ADDITIONAL CHARGE BEING FILED AGAINST YOU FOR VIOLATING YOUR PROMISE TO APPEAR WITH A FINE NOT TO EXCEED \$200.00 AND ADDITIONAL STATE FEES WILL BE INCURRED. IF YOU DO NOT MAKE FINAL DISPOSITION ON YOUR CITATION YOU ARE SUBJECT TO BEING DENIED RENEWAL OF YOUR DRIVER'S LICENSE BY THE TEXAS DEPARTMENT OF PUBLIC SAFETY.**

This letter is furnished as a courtesy to you by the Justice Courts of Henderson County, Texas to assist you in making disposition of the charge(s) against you. **Please note: The Judge cannot discuss the merits of a pending judicial proceeding prior to trial.** This means the Judge cannot discuss your citation with you prior to trial. **NO PERSONAL CHECKS ACCEPTED** All payments should be made **Payable to Henderson County by Cashiers Check or Money Order only.** If paying cash you must have the exact amount.

**APPEARANCE AND PLEA**

**YOU MUST APPEAR:**

- **IN PERSON** on the appearance date given on your citation
- **BY MAIL**, enter your appearance by completing the plea form on the reverse side of this sheet and returning to the Court. When entering a plea of guilty and paying your citation by mail, send a copy of your citation.
- If you plea not guilty, a trial date will be set and you will be notified accordingly.

**PERSONS UNDER 17 YEARS OF AGE:**

- Must appear with a parent or legal guardian or proof of marriage.
- Must appear before the Judge, no pleas by mail.

**PERSONS UNDER 21 YEARS OF AGE (ALCOHOL RELATED OFFENSES):**

Must appear before the Judge, no pleas by mail

- Must appear with a parent or legal guardian if under 18 years of age.

**PERSONS CHARGED WITH TOBACCO OFFENSES:**

- Must appear before the Judge, no pleas by mail
- Must appear with a parent or legal guardian if under 17 years of age.
