There were no citizens' comments.

Motion made by Comm. Geeslin and seconded by Comm. McHam to approve the Minutes from the previous meeting held on November 6<sup>th</sup>, 2018, as listed on copy in file. Voted unanimously by those present.

Motion made by Comm. McKinney and seconded by Comm. Geeslin to approve minutes from the IT meeting on July 11th, 2018, for filing purposes only. Voted unanimously by those present.

Motion made by Comm. McKinney and seconded by Comm. Geeslin to approve canvassing the votes from the November 6<sup>th</sup>, 2018 General Election of Henderson County. Voted unanimously by those present.

Motion made by Comm. McKinney and seconded by Comm. McHam, with great concern to approve the Resolution accepting the election results by the voters of the Emergency Service District Number 6, adoption of a sales tax in ESD #6. Motion carries 3 to 1. Comm. Geeslin opposed.

Motion made by Comm. Geeslin and seconded by Comm. McHam to approve the Resolution approving and authorizing a Property Tax Abatement Agreement in the jurisdiction of Henderson County, Texas of Biomerics, FMI, LLC. Voted unanimously by those present.

Motion made by Comm. McHam and seconded by Comm. McKinney to approve an InterLocal Agreement for a Harvest Garden at the Henderson County Regional Fair Park. Voted unanimously by those present.

Motion made by Comm. Geeslin and seconded by Comm. McHam to approve the Sheriff's Office to enter into an InterLocal Agreement with LaPoynor ISD to furnish a School Resource Deputy, giving Judge Sanders authorization to sign. Voted unanimously by those present.
