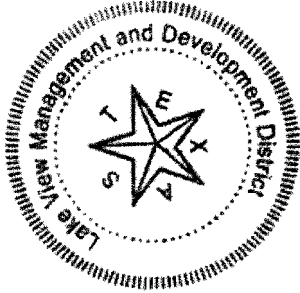

Notice is hereby given pursuant to V.T.C.A., Government Code §551, that the Board of Directors of Lake View Management and Development District (the "District") will hold a special meeting on Tuesday, October 29, 2019 at 2:00 p.m. at 3899 Maple Avenue, Suite 300, Dallas, Texas 75219, for the following purposes:

1. Public communications and comments;
2. Review and approve Minutes of the September 24, 2019 Board of Directors Meeting;
3. Review and approve annual financial report for fiscal year ended July 31, 2019;
4. Review and approve documents in connection with issuance of the District's Series 2019 Road Bonds and related closing scheduled for October 29, 2019, including, but not limited to, closing statement and fund disbursements;
5. Review and approve Report on Applying Agreed-Upon Procedures for Construction, Engineering and Related Costs Reimbursable to Long Cove Development, Inc. from Proceeds of the Series 2019 Road Bonds, and authorize reimbursement following closing of sale of said Bonds;
6. Consider review and approve Amended District Information Form, and take any action in connection therewith;
7. Hear update from developer/general manager and take any action as may be necessary;
8. Hear engineer's report and take any action as may be necessary in connection with:
 - a. Status of construction projects within the District;
 - b. Authorizing preparation of construction plans/specifications;
 - c. Approval/ratification of construction plans and specifications;
 - d. Approval/ratification of advertising for bids for contract(s);
 - e. Approval/ratification of District purchases and award of construction contract(s); and
 - f. Approval/ratification of contractor pay estimates, change orders.
9. Discuss fire protection services and take any action necessary or appropriate in connection therewith;
10. Review and approve bookkeeping report, payment of invoices, and related bookkeeping matters, and take any action as may be necessary;

11. Consider any other matters that may come before the Board, and the taking of any action necessary or appropriate in connection therewith; and
12. Adjournment.
