Brent Muecke, 5880 CR 4512, LaRue, TX stated updates to the proposed budget were not publicized and the Senior Citizen Facility needs attention.

Motion made by Comm. Geelsin and seconded by Comm. Lawrence, to approve the Minutes from the previous meeting held on August 26^{th} , 2014, as listed on copy in file. Voted unanimously by the court.

Carolyn Tyler of Henderson County 4H commented on and presented two students who participated in the 4H Nationals. Amanda Cooper and Nolan Newnan stated the events they competed in as well as their placement in each. Three students out of the 336 in Henderson County went to Nationals. Henderson County 4H brought home the National trophy which was displayed for the Court.

Brent Muecke stated the Volunteer Fire Departments

needed an increase.

Comm. McKinney stated the tax increase would total .477984 cents. The rate for last year was .472658. The increase is for Road and Bridge which has not been increased for several years.

Comm. Geeslin concurred with Comm. McKinney stating the tax increase is less than a case of bottled water.

Motion made by Comm. McKinney and seconded by Comm. Thomas to close the Public Hearing on proposed FY2015 Tax rate for Henderson County. Voted unanimously by the court.
