Motion made by Comm. Thomas and seconded by Comm. Tuley to approve donating an 8' x 40' storage container listed for \$1,000.00 to the Athens Animal Rescue Shelter. Voted unanimously by the court.

Pace McDonald, Blue Water Key POA, President discussed getting the Blue Water Key Subdivision, located in Precinct #3, in the Henderson County Road Maintenance; the POA was able to raise money to put towards the maintenance of the roads.
