- 10. Receive and possibly take action to approve Operating Permit for well #5 for HRC Cherokee Tree Farm LP, located at 5834 FM 855 West, Bullard, TX. Total usage applied for is 6,570,000 gallons or 20.17 acre-feet annually at an estimated rate of withdrawal of 80 gallons per minute.
