There were no Citizens Comments.

Motion made by Comm. McKinney and seconded by Comm. Geeslin to approve the IT Minutes from the previous meeting held on April 20th, 2015, for filing purposes only. Voted unanimously by those present.

Josh Brock, IT Director discussed the participation agreement with Tyler DataXchange. This agreement was discussed in the IT Committee meeting held April 20th, 2015. This agreement allows the County to view criminal information from every county that has Odyssey and is in DataXchange with Tyler Technologies. Motion made by Comm. McKinney and seconded by Comm. Geeslin to approve the DataXchange Participation Agreement with Tyler Technologies and Henderson County, giving Judge Sanders authorization to sign. Voted unanimously by those present.

Comm. Geeslin discussed ratification of the Henderson County Road Maintenance Program for 6.61 miles of county roads within the Brierwood Bay Subdivision. The roads that will be in the maintenance program will be Brierwood Drive to Panarama Drive, Panarama Drive, Holly Hills, Forest Hill Drive, Driftwood, Autumn Trail, Valley View Drive, Cutter Drive, Phillip Place, Carol Way, Coral Drive, Lindy Lane and Tanglewood totaling the 6.61 miles. Brierwood Bay Property Owners Association is now Dis-Annexed from the City of Coffey City as referenced in Cause Number 2014C-0317, located in Pct. 4. Motion made by Comm. Geeslin and seconded by Comm. Thomas to approve to ratify Henderson County Road Maintenance Program for the County Roads within the Brierwood Bay Subdivision, located in Pct. 4. This due to the Dis-Annexation Ordinance of Brierwood Bay Property Owners Association and Coffee City, as referenced in Cause Number 2014C-0317. Voted unanimously by those present.
