Motion made by Comm. Richardson and seconded by Comm. Spivey to approve the contract with Tyler Technologies ERP for Financial Software related to ARPA State and Local Fiscal Recovery Fund project, giving Judge McKinney authorization to sign. Voted unanimously by the court.

Motion made by Comm. McHam and seconded by Comm. Tuley to approve the amended Fund Balance Policy for Henderson County. Voted unanimously by the court.

Motion made by Comm. McHam and seconded by Comm. Richardson to approve the request from Red Hill Cemetery to assist with labor and equipment for repairs to a drive area on the North section of the cemetery, located in Precinct #3. Voted unanimously by the court.

Richardson to approve the right-of-way permits with Charter-Spectrum to install one (1) class 5 - 30' pole with supply cabinet and trench approximately 20 ft. of 1-2" HDPE conduit on CR 3407 and on CR 3410, CR 3407, CR 3426, CR 3426 A, CR 3406, CR 3405, CR 3409 to install approximately 35,512' of aerial fiber optic cable attached to existing poles, and approximately 120' of underground conduits e/w fiber optic cable and approximately 2 vaults within the right-of-way of CR 3410, CR 3407, CR 3426, CR 3426 A, CR 3406, CR 3405 and CR 3409; and install approximately 26,950' of aerial fiber optic cable attached to existing poles and approximately 1,912' of underground conduits e/w fiber optic cable and approximately 8 vaults within the right-of-way of CR 3403, CR 3408, CR 3412, Pheasant Dr., Dove Lane and Phoenix South Drive and CR 3302, CR 3400, CR 3402, CR 3300 and Noonday Road to install 19,420' of aerial fiber optic cable attached to existing poles and approximately 5,270' of underground conduits e/w fiber optic cable, and approximately 12 vaults within the right-of-way of CR 3302, CR 3400, CR3402, CR 3300 and Noonday Road and (CR 3411 being in Precinct #4), giving Comm. McHam authorization to sign. Motion carries 4 to 1. Comm. Tuley opposed.
