Motion made by Comm. Tuley and seconded by Comm. Spivey to approve the minutes as amended from the previously held meeting of Commissioner's Court on January 23<sup>rd</sup>, 2024. Voted unanimously by the court.

Motion made by Comm. McHam and seconded by Comm. Richardson to approve accepting the Racial Profiling Report form the Henderson County Fire Marshal, for filing purposes. Voted unanimously by the court.

Motion made by Comm. Spivey and seconded by Comm. McHam to approve a request from Justice of the Peace Precinct 5 to fill a possible vacant position. Voted unanimously by the court.

Motion made by Comm. Spivey and seconded by Comm. Richardson to approve accepting a donation in the amount of \$4,000.00 from the Tool Cemetery Association for material that is need to blade and overlay the road inside the cemetery, located in Precinct #1. Voted unanimously by the court.

Motion made by Comm. Spivey and seconded by Comm. Tuley to approve an Interlocal Agreement for City-County Plat Approval with the City of Tool, Texas, giving the City of Tool authority and exclusive control over platting within its ETJ, giving Judge McKinney authorization to sign.

McHam authorization to sign. Motion carries 4 to 1. Comm. Tuley opposed.
