Judge Sanders called the meeting to order @ 9:03 A.M.

Angela Wilson, 588 CR 3925 in the Dal-High Subdivision, Athens, TX, off of Highway 175 West just outside Loop 7 discussed her and her neighbors concerns of the proposed development of the New Haven Government Apartment Complex being built in the back-yard of the Dal-High Subdivision. Angela stated she went door to door getting a petition signed by 60 of the neighbors in the subdivision, stating that they are opposed to the development of the New Haven Government Apartment Complex. Being a single parent she understands the need for low income housing yet in the past, the low income housing has brought more crime than it has benefit to the community. Without screening this would be detrimental to our community, safety comes first for our families.

Don Ball, New Haven I, LP, discussed in detail the gated 80 unit low income housing complex development, located off of 175 West just outside Loop 7 in Precinct 3. Motion made by Comm. McKinney and seconded by Comm. Geeslin to dis-approve the resolution for a proposed 80 unit apartment complex development to be built in Henderson County, located in Precinct 3. Voted unanimously by the court.

Ann Marie Lee, County Auditor discussed the out-of-state conference stating it is a cruise out of Galveston. Ann Marie stated that the cruise is cheaper than the conference in Austin.
