There were no citizens' comments.

Motion made by Comm. Hayes and seconded by Comm. McHam to approve the Minutes from the previous meeting held on April 4<sup>th</sup>, 2017, as listed on copy in file. Voted unanimously by the court.

Motion made by Comm. Geeslin and seconded by Comm. McKinney to approve proclaiming the month of April as Domestic Violence and Sexual Assault Awareness Month. Voted unanimously by the court.

Motion made by Comm. Geeslin and seconded by Comm. McHam to approve proclaiming April 12<sup>th</sup>, 2017 as Telecommunication Operator Appreciation Day. Voted unanimously by the court.

Motion made by Comm. McKinney and seconded by Comm. Hayes to approve the refund request in the amount of \$4,090.83 for overpayment of taxes from the Henderson County Tax Assessor/Collector. Voted unanimously by the court.
