Michael Bynum called the Meeting to order at 1:30 P.M.

1. Consider and Take Action to approve the Minutes of previous IT Committee Meeting.

Motion made by Comm. Hayes and seconded by Sheriff Hillhouse to accept the minutes of the April 4th, 2018 IT Meeting, for filing purposes only. Motion passes.

2. Consider and Take Action on issues related to the Odyssey Project.

Diane – prosecutor business project review – the County Attorney's Office and the District Attorney's Office were supposed to meet with Patrick Green in April and wasn't able to get a good date for all to meet. There is a confirmed date of May 29th and 30th, 2018 to meet with Patrick Green.

3. Consider and Take Action on software for the Henderson County Animal Shelter.

Lynn McCauley – discussed software for the Henderson County Animal Shelter, stating the shelter doesn't have a system that will track animals with Microchips and if the animals have been in the shelter, adopted or lost before. Henderson County Animal Shelter has Quickbooks now for their accounting system. Michael – will check with Smith County about their software Shelter Pro. Motion made by Judge Pollock and seconded by Comm. Hayes to table taking action on the software for the Henderson County Animal Shelter to get more information on the software. Motion passes.

4. Consider and Discuss issues related to the software and hardware requirements for the Tax Assessor/Collector. Peggy – discussed the server needing to be replaced. The server started in operation in 2007. The delinquent tax attorneys McCreary, Veselka, Bragg and Allen P.C. would pay for the new server as part of their package. Peggy discussed continuing to use NetData stating it is a better software company for the tax office. When the Tax office needs assistance they are able to call NetData and get assistance with any issue, tax rate calculations, they work with the Tax Office when they send to the printers and help throughout the year when adding entities. Peggy – checked into other software companies and it wasn't user friendly, but may be able to be customized. Kaufman County uses a software and it took about a year to get trained. The second software company that they checked into was Spindle Media and they are just now going online with their first client, and this software has more steps to run reports etc. than NetData. Peggy - the County will need to decide if they want go with an online option or a server. To purchase a new server: Option 1 – Power 9 S914 – total cost solution Estimate: \$48,700. To purchase NetData private cloud hosting cost: Option 2 - \$19,000 per year (3-year term), a one-time migration cost: \$2,500 and VPN devices: \$2,000 per device upfront/\$500 a year for maintenance per device as needed. Josh - Option 1 is the better choice for the County. Peggy - if we go with Option 2 cloud hosting, if there is an outage, it would only be 15 minutes at the most they would be down. Judge Pollock - would McCreary pay for Option 2? Peggy - yes, whichever option the County decides to go with they would pay for it. Judge Pollock - if McCreary is willing to pay for either option, the cloud would be the best way to go because everyone seems to be going with the cloud in the future.

5. Consider and Discuss IT Director Report.
